Dear President Biden:

On behalf of the US Council of Muslim Organizations and the undersigned American Muslim groups, congratulations on your inauguration as the 46th President of the United States. We also extend our warmest congratulations to Vice President Kamala Harris on her historic achievement.

As you and Vice President Harris take the reins of our nation at this profound and difficult moment, we pray that God lights the way for you to heal our country, unite Americans in the pursuit of justice, and advance peace and prosperity for all.

Last week, your administration took an important and commendable step in the right direction by repealing the Trump Administration's Muslim Ban, which caused untold damage to American families and people around the world.

On behalf of our community, thank you. American Muslims—many of whom volunteered for your campaign in critical swing states, and most of whom supported your candidacy nationwide—greatly appreciate your swift action on this issue. Our community now stands ready to work with you to advance positive change in other areas. To that end, we write to share three requests.

I. Including American Muslims in Every Level of Government

During the campaign last year, you pledged, "As president, I'll work with you to rip the poison of hate from our society to honor your contributions and seek your ideas. My administration will look like America, with Muslim Americans serving at every level."

You have already taken welcome steps towards fulfilling this pledge by appointing several talented and experienced American Muslims to important staff positions. However, a Muslim was not included among your 15 cabinet nominees. In the coming days, we encourage you to include American Muslims "at every level" by also nominating a member of our community to a cabinet-level position, or as a deputy to a cabinet secretary.

We also encourage you to appoint an American Muslim to serve as a "Special Envoy to Monitor and Combat Islamophobia" at the State Department, on par with the existing Office of the Special Envoy to Monitor and Combat Anti-Semitism. From here in America to France to China to Myanmar to India, anti-Muslim bigotry poses an interconnected threat to Muslims worldwide. Our nation should play a major role in confronting that global threat.

American Muslims represent the third largest and the most diverse religious group in our nation. Our participation in every level of government—including the cabinet and especially in areas of government that directly impact our community—is critical to fulfilling your vision of a diverse administration that reflects America.





II. Pursuing Systemic Policy Reforms Recommended by American Muslims

We encourage your administration to pursue the systemic policy reforms recommended by the Council on American-Islamic Relations – a member organization of USCMO – in its report, "The First 100 Days: Restoring the Rights of American Muslims and Advancing Justice for all Americans."

Endorsed by dozens of Muslim organizations, these recommendations would advance racial equality, religious freedom, criminal justice reform, and economic opportunity here at home, as well as peace abroad, by:

- Ending national security overreach
- Banning bigoted & discriminatory immigration policies
- Countering racism in policing
- Protecting constitutional rights in schools, workplaces and elsewhere
- Defending the constitutional rights of federal and state prisoners
- Supporting a progressive and transformative foreign policy

The report, which we shared with your transition team in December, includes specific recommendations to advance each of these goals.

III. Meeting with American Muslim Community Leaders

We encourage your administration to regularly meet, in-person or virtually, with American Muslim community leaders and organizations to hear from our community members on these and other issues, lay out your vision for the future, and enlist the assistance of our community in supporting your agenda.

By taking these three initial steps—appointing American Muslims to every level of your administration, pursuing systemic policy change, and meeting with American Muslim leaders—your administration can highlight the important role that American Muslims play in our society and advance just policies that benefit all Americans.

As the largest and most diverse umbrella organization for American Muslim groups in our nation, USCMO stands ready to support you in the pursuit of such efforts. So does the broader American Muslim community, including the other signatories to this letter.

May God make you equal to the task before you, grant you the blessing of guidance in your decisions, and aid you in the urgent quest to restore the health and welfare of the American people while ensuring equitable representation for all.

We hope to hear from you soon, and we look forward to working with you to advance positive change for our nation, insha Allah (God willing).
